With reference to the above subject.

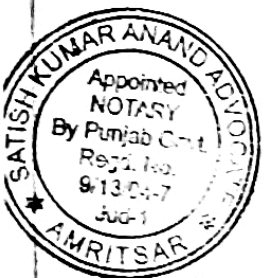

1. In future on receipt of any complaint/inspection if it is found that to obtain no objection certificate, you have submitted application to the Government on the basis of wrong information and non compliance of instructions of the Punjab Government issued from time to time and have not accepted the written conditions submitted in the affidavit then in such circumstances, no objection certificate will be withdrawn.

2. Education of Punjabi Subject upto 10th class is your school will be compulsory and C.B.S.E. New Delhi in such school will make compulsory arrangement to take examination of Punjabi and in the case of non compliance, no objection certificate will be withdrawn immediately.

3. The School Management after taking affiliation of C.B.S.E. New Delhi will be bound to give salary & other allownces to the teaching staff and non teaching staff equal to the Govt. employees

4. You and your management should make it assure that on demand of any information from Distt: Education Officer or any senior officer of the Education Department, you should make it available and also required co-operation will be given.

5. You school should have obtain fire safety certificate and building safety certificate for the year 2008-09 and for future it should be got renew within a period of 90 days and its copy should be submitted to the Government for information

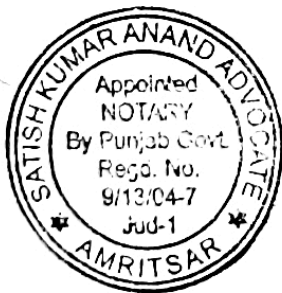
